Development Update

Tiffany Massy highlighted current funders and grants received as well as updated the board on the FY18 development plan goals. Two Palmetto Basics anchor sponsorships sold so far in FY18: Bon Secours St Francis Hospital System and Primrose School of Greenville. Also, Greenville First Steps was a recipient of the GHS Healthy Greenville 2036 grant for \$270,000 over 3 years to support childcare scholarships. New in 2018 will be an annual fund campaign featuring 100% staff and board giving.

Palmetto Basics Update

Anne Lee talked about what it means to be a Palmetto Basics Champion and asked that each board member's organization commit to be a champion or to get a community organization signed on. Anne Lee highlighted this work is being implemented through community organizations, empowering them to be advocates. As of board meeting, 66 Palmetto Basics champions signed on and 41 volunteers to serve on focus groups.
