Notes on documents for approval:

Budget and Renewal Plan documents:

- Approval of FY24 Budget Spending Plan (attachment in folder: labeled "BSP FY24". Spending plan is similar to one presented to Board in early April, except for two changes:
 - 9. There was a formula error in calculating 8% increase for **salaries**. \$4,500 more was budgeted in salaries than needed for 8% increase. Additional dollars were moved to 55-101-537300 (Contract services) for future projects. (Good eye Travis Wharton)
 - 10. 320- 4K supports changed to 180-Community Outreach. GFS uses funds to add enrichment activities to existing public school 4k services (art, theatre, yoga, parenting programs) According to SCFS revised program standards- the project as we support it (enrichment and program enhancement) doesn't fit with 320 program standards (which is more focused on increasing enrollment in programs). We will move funding to 180-Community outreach. No changes to programming- just change of where program lives.
