#### A few notes:

**Searchlight**: A local group of volunteers working to increase access to quality childcare. GFS is partnering with them to host meetings with churches to explore use of Sunday School space. Dollars will be used to cover costs of meetings, documents/resources

**Center for Developmental Services**: Made an ask of First Steps to assist with some onetime costs associated with facility security improvements

**Greenville's Gift** provides newborn kits (diapers, clothes, books) for NFP and Nurturing Parenting families. We are working on a \$10,000 grant to allow them to also provide resources for Family Connects clients who are Medicaid eligible. This \$5,000 would be a required match for this grant

**Endowed fund**: GFS strategic plan goal to grow endowed fund to \$800,000 by June 2026. Moving \$80,000 would increase Endowed Fund to \$673,000

**Family Connects fund:** This balance will cover entire FY24 MOA with DHEC (\$832,397), Family Connects International MOA (\$75,000), Smoak PR MOA (\$20,000),6 and remaining balance will roll over to FY25

# Section VI(b) Composition

#### **Current:**

The Board of Directors of the Corporation (the "Board") shall be composed of members as described in the Enabling Act. The membership of the Board of Directors shall be determined as follows: (1) The Corporation shall maintain a total minimum membership of twelve (12) and a maximum membership of thirty (30) elected, appointed and designated individuals. Elected and appointed Directors shall comprise of a voting majority of the board. (2) No more than four (4) from any of the following categories may be elected to sit on the Board. (a) prekindergarten through primary educator; (b) family education, training, and support provider; (c) childcare or early childhood development/education provider; 4 (d) healthcare provider; (e) local government; (f) nonprofit organization that provides services to families and children; (g) faith community; (h) business community; (i) philanthropic community; and (j) parents of preschool children. (3) To assure that all areas of the county or multicounty region are adequately represented and reflect the diversity of the coverage area, the county legislative delegation may appoint up to four (4) Directors to the Board. Of these Directors, two (2) are appointed by the Senate members and two (2) by the House of Representatives of the delegation from persons with resources, skills, or knowledge that have specific interests in improving the readiness of young children for school. (4) Each of the following entities located within the Corporation's coverage area shall designate one (1) member to serve as a member of the Board: (a) county department of social services; (b) county department of health and environmental control; (c) Head Start or early Head Start; (d) county library; and (e) each of the school districts in the county

#### **Proposed Revision:**

The Board of Directors of the Corporation (the "Board") shall be composed of members as described in the Enabling Act. Board must be comprised of individuals with resources, skills, knowledge, and interest in improving the readiness of young children for school. The membership of the Board of Directors shall be determined as follows: (1) The Corporation shall maintain a total minimum membership of seven (7) and a maximum membership of fifteen (15) elected and appointed individuals.

# The board shall consist of:

- Up to four (4) members elected by the local First Steps board of directors. Elected members shall be elected to serve a four (4) year term, and may be re-elected for a second four (4) year term, for a total of eight (8) consecutive years.
- Up to nine (9) members appointed by the Greenville Legislative Delegation (or their designee) to include six (6) Appointed Directors from the community, one (1) representing the Department of Social Services, one (1) representing Head Start/ Early Head Start, and one (1) representing SC Department of Health and Environmental Control. Legislative delegation shall set terms of service for Legislative delegation appointees.
- Up to one (1) appointed member from the Greenville Library System, appointed by Greenville County Council. Council shall set terms of service for Library appointee.
- Up to one (1) appointed member from Greenville County Schools, appointed by Greenville County School Board. Greenville County School board shall set terms of service for School District appointee.

Section VI(c). Terms, Resignation, Removal and Vacancies.

#### **Current:**

Terms. Except in case of earlier resignation, removal, death or other inability to serve, the term of service of each Director shall expire four (4) years from such Director's date of election or appointment. A Director may not serve more than eight (8) consecutive years. A Director elected or appointed to fill a vacancy in a Directorship caused by resignation, removal, death or other inability to serve, shall serve out the unexpired term to which he is elected or appointed.

## Proposed:

Terms. Except in case of earlier resignation, removal, death or other inability to serve, the term of service of each Director shall expire in accordance with terms set by appointing entity, or four (4) years from date of election if elected by board.
