Update on SEACHlight and Childcare Outreach efforts

Derek provided an update on the childcare landscape and the needs of the community to expand access to childcare throughout the community. Information on attached form includes a projected shortage of 4,500 childcare slots (primarily infant and toddler). Presentation was made for information only, board members expressed willingness to further explore needs and opportunities for First Steps involvement in upcoming meetings.

Beth and Derek presented the YTD program summary- including comparison information to FY24 goals AND 2024-2026 Strategic Plan 3 year goals. Data is included in board packet. Staff also presented projected financials for FY25 (numbers will not be finalized until SCFS staff provide final budget numbers. One key note- FY25 will include a \$100,000 reduction of private income currently used for internal staffing positions- may require a staff reduction to cover shortfall. No action taken.

After Board exited Executive Session motion was made to accept Executive Director Evaluation (as presented by the Board Executive Committee) and to approve \$20,000 in onetime bonuses funded with a portion of surplus private funds from conclusion of Triple P Greenville multi-year grant (\$8,000 for Executive Director and \$12,000 to be distributed by Executive Director to other staff as appropriate). Motion made by JoKeitha Seabrook, Second Carrie Silver. Motion carried.
